### Syllabus for

### **BIO 310—Microbiology Laboratory**

1.0 Credit Hours Fall 2016

### I. COURSE DESCRIPTION

An introduction to microbiology lab techniques including isolation, cultivation, characterization, and identification of micro-organisms. (One 3-hour lab per week).

Corequisite: BIO 310 Lecture.

Lab fee: \$100.

### II COURSE GOALS

The purpose of this course is to enable the student to learn laboratory techniques and participate in experiments.

#### III. STUDENT LEARNING OUTCOMES FOR THIS COURSE

As a result of successfully completing this course, the student will be able to do the following:

- 1. Prepare slides of microorganisms from different source materials.
- 2. Perform the staining procedures included in this course and obtain satisfactory results.
- 3. Isolate and identify microorganisms in pure culture.
- 4. Perform serial dilutions to quantify and enumerate bacteria.
- 5. Determine the morphological, nutritional, and physiological characteristics of an organism by using the standard tests in the laboratory manual.
- 6. Describe the importance of microbiological techniques in human diagnosis of infectious disease.
- 7. Describe three (3) applications of microbiological techniques in human life and environment.
- 8. Demonstrate ability to use Bergey's <u>Manual of Determinative Microbiology</u>, to identify microorganisms.
- 9. Quantify bacterial growth using a spectrophotometer.
- 10. Demonstrate the effectiveness of certain antibiotics using Kirby-Bauer test.
- 11. Demonstrate effect of osmolarity and pH on growth of bacteria.
- 12. Recognize and identify stages in viral infection of bacteria.
- 13. Utilize effectively the compound microscope and explain fully the mechanisms of its operation.

### V. POLICIES AND PROCEDURES

## A. University Policies and Procedures

- 1. Attendance at each class or laboratory is mandatory at Oral Roberts University. Excessive absences can reduce a student's grade or deny credit for the course.
- 2. Students taking a late exam because of an unauthorized absence are charged a late exam fee.
- 3. Students and faculty at Oral Roberts University must adhere to all laws addressing the ethical use of others' materials, whether it is in the form of print, electronic, video, multimedia, or computer software. Plagiarism and other forms of cheating involve both lying and stealing and are violations of ORU's Honor Code: "I will not cheat or plagiarize; I will do my own academic work and will not inappropriately collaborate with other students on assignments." Plagiarism is usually defined as copying someone else's ideas, words, or sentence structure and submitting them as one's own. Other forms of academic dishonesty include (but are not limited to) the following:
  - a. Submitting another's work as one's own or colluding with someone else and submitting that work as though it were his or hers;
  - b. Failing to meet group assignment or project requirements while claiming to have done so;
  - c. Failing to cite sources used in a paper;
  - d. Creating results for experiments, observations, interviews, or projects that were not done;
  - e. Receiving or giving unauthorized help on assignments.

By submitting an assignment in any form, the student gives permission for the assignment to be checked for plagiarism, either by submitting the work for electronic verification or by other means. Penalties for any of the above infractions may result in disciplinary action including failing the assignment or failing the course or expulsion from the University, as determined by department and University guidelines.

- 4. Final exams cannot be given before their scheduled times. Students need to check the final exam schedule before planning return flights or other events at the end of the semester.
- 5. Students are to be in compliance with University, school, and departmental policies regarding the Whole Person Assessment requirements. Students should consult the Whole Person Assessment handbooks for requirements regarding general education and the students' majors.
  - a. The penalty for not submitting electronically or for incorrectly submitting an artifact is a zero for that assignment.
  - b. By submitting an assignment, the student gives permission for the assignment to be assessed electronically.

### B. Course Policies and Procedures

1. Attendance policy.

Oral Roberts University tries to educate and train you to succeed in a wide variety of situations, which usually require that you be present, punctual and prepared to do your job well. The attendance policy of this course is to prepare you for a responsible, successful post-ORU reality. Your sick or other emergency leaves equal the number of times you meet in a week, i.e., one day.

Any additional absences will cost you. One absence 1.5% and two absences 3%. There are no exceptions to this policy except for an official University activity.

## 2. Grading

Ten (10) quizzes based on questions at the end of each exercise and the lab text materials (10 points each) are given in the laboratory during the semester. No make-up quizzes are given. Administratively excused absences are made up by making arrangements with the instructor.

Reports for Unknowns are due on the date specified to you by the instructor at the beginning of the semester. There will be no exceptions to this policy.

### 3. Exam Policies

- a. *Makeup Exams*—Any examination not taken at the scheduled time due to an excused absence must be made up at a time arranged with or by the instructor. **Generally, tests missed for an unexcused absence cannot be made up.** If a test absence is allowed to be made up, the University late test fee must be paid in advance. Absence on exam days will cost you 20 points
- b. *Final Exam*—The final exam is NOT optional. ORU requires that a final exam be taken at the scheduled time, unless written permission from an authorized person is received; otherwise, makeup of an exam should be scheduled in advance of the exam.

## 4. Other Information

- a. Scheduled Meetings—One 3-hour laboratory meeting is scheduled per week. Usually not all of this time will be needed; however, there are a few instances in which the students need to come in at times other than the regularly scheduled time to evaluate their experiments.
- b. Assignments—The laboratory exercises are performed according to the schedule listed below. It is important for each student to read the material pertinent to the laboratory exercise before the laboratory period.
- c. Incompletes—An Incomplete ("I") is given for work that is incomplete at the time final grades are given due to circumstances beyond the student's control. It is the student's responsibility to personally submit to his or her instructor a written petition for an "incomplete" before final exam week and receive back written approval. If granted, the student must make up the incomplete work within one semester, or the "incomplete" automatically becomes an "F." Incompletes are not granted to students who have procrastinated or otherwise neglected the course by absences, late work, etc.
- d. No laboratory experiments may be omitted. Excused absences are made up by making arrangements with the instructor. If a student misses three or more labs, a grade of "F" is automatically given.

5. Whole Person Assessment Requirements
A laboratory report on the Identification of an Unknown Bacterium will be used to satisfy your Whole Person Assessment requirements for the Department of Biology and corresponds to the critical thinking outcome (2A) for this course.
