Syllabus for SPA 499--Senior Paper 3 Credit hours Fall 2017

I. COURSE DESCRIPTION

Directed individual study of seniors pursuing research and the writing of the required senior paper.

Prerequisite: None Lab fee: None

II. COURSE GOALS

The purpose of this course is to enable the student to express himself or herself in the appropriate foreign language by demonstrating that they understand their topic to such a degree that they are able to analyze and critic their subject by using major research tools such as the MLA Bibliography and major critical works and complete works of the discussed authors.

III. STUDENT LEARNING OUTCOMES FOR THIS COURSE

Upon successful completion of this course, through research and sessions with the assigned senior paper advisor, the student will be able to do the following:

- A. Prepare a bibliography of the major material written on the student's chosen subject.
- B. Select from the bibliography of the works, which are most pertinent. These will serve to help support the thesis statement, or serve as a foil to, or basis for, original insights and conceptualizing.
- C. Follow the techniques of research and composition that will aid the student in producing the final paper, such as keeping note cards, bibliography cards, and making a final outline.
- D. Prepare a fully documented paper in rough draft, following the form outlined in the current MLA Style Sheet.
- E. Demonstrate through writing the ability to comprehend Spanish and/or Spanish-American literature, history and other Spanish writings.
- F. Demonstrate in writing knowledge of global, historical, and aesthetic perspectives of research findings.
- G. Demonstrates mastered skills requisite for foreign language research and original synthesis of the issues and insights relevant to the student's chosen subject by completing a fully documented paper that clearly supports the student's thesis statement.

V. POLICIES AND PROCEDURES

A. University Policies and Procedures

- 1. Attendance at each class or laboratory is mandatory at Oral Roberts University. Excessive absences can reduce a student's grade or deny credit for the course.
- 2. Students taking a late exam because of an unauthorized absence are charged a late exam fee.
- 3. Students and faculty at Oral Roberts University must adhere to all laws addressing the ethical use of others' materials, whether it is in the form of print, electronic, video, multimedia, or computer software. Plagiarism and other forms of cheating involve both lying and stealing and are violations of ORU's Honor Code: "I will not cheat or plagiarize; I will do my own academic work and will not inappropriately collaborate with other students on assignments." Plagiarism is usually defined as copying someone else's ideas, words, or sentence structure and submitting them as one's own. Other forms of academic dishonesty include (but are not limited to) the following:
 - a. Submitting another's work as one's own or colluding with someone else and submitting that work as though it were his or hers;
 - b. Failing to meet group assignment or project requirements while claiming to have done so;
 - c. Failing to cite sources used in a paper;
 - d. Creating results for experiments, observations, interviews, or projects that were not done;
 - e. Receiving or giving unauthorized help on assignments.

By submitting an assignment in any form, the student gives permission for the assignment to be checked for plagiarism, either by submitting the work for electronic verification or by other means. Penalties for any of the above infractions may result in disciplinary action including failing the assignment or failing the course or expulsion from the University, as determined by department and University guidelines.

- 4. Final exams cannot be given before their scheduled times. Students need to check the final exam schedule before planning return flights or other events at the end of the semester.
- 5. Students are to be in compliance with university, school, and departmental policies regarding Whole Person Assessment requirements. Students should consult the Whole Person Assessment handbooks for requirements regarding general education and the students' majors.
 - a. The penalty for not submitting electronically or for incorrectly submitting an artifact is a zero for that assignment.
 - b. By submitting an assignment, the student gives permission for the assignment to be assessed electronically.

B. Department Policies and Procedures

1. Class Assignments

a. Students need to come to class with the appropriate textbooks, course materials, and other supplies as designated by the professor.

- b. Professors may refuse to accept an assignment if it has inappropriate content, does not meet the assignment's criteria (e.g., not typed, incorrectly documented), is incomplete, is suspected of plagiarism, or is turned in too late.
- 2. **Tardies**—Tardies are an inconvenience to the other class members and the professor, and they prevent the late student from obtaining maximum value from the class. Therefore, excessive tardies may adversely affect the semester grade. It is to the student's advantage to make sure that the professor is informed immediately following the close of the class that the student was tardy and not absent. It is not the professor's responsibility to stop the class to mark the tardy; the student is the one responsible for conveying that information immediately following that class, not at a later time.

3. Late Work

- a. The student is responsible for obtaining class assignments and material covered during an absence, and all work is expected to be completed as scheduled. Late work may result in a lower grade. An absence is not an excuse for turning in late work or for being unprepared with assignments for the class following the absence. Computer or printer malfunction does not constitute an excuse for late work; students should have their work prepared in time to ensure that they can get it proofread, edited, and printed prior to the instructor's due date. These responsibilities assist the student in professional development.
- b. Any test taken late (except if the absence is administratively excused) incurs the ORU late exam fee (\$15), which must be paid before the late test can be taken.
- c. Assignments missed because of administratively excused absences are accepted with no penalty. Generally, assignments missed from an excused absence, such as sickness or family crises, can be made up and the instructor should be notified as soon as possible to reach an agreement on due dates and possible penalties. Each instructor has his or her own late-work policy that is given to students at the beginning of a course, so a teacher may decide that work missed because of an unexcused absence cannot be made up. Instructors use their own judgment in accepting late work resulting from all other absences. In cases where absences can be anticipated, such as for non-University sponsored mission trips, the work should normally be submitted prior to the absence.

4. Attendance

a. **Excused and Unexcused Absences**—As stated in the university policy section of this syllabus, class attendance is mandatory, but because unavoidable circumstances can prevent perfect attendance, each student is allowed to miss class the number of times per week a class meets. This allowance is intended for illness, personal business, and emergency. Work missed because of an excused absence (e.g., illness, family emergency) can be made up; however, it is up to the teacher's discretion whether or not to accept work missed due to an unexcused absence (e.g., oversleeping, skipping class). If a student exceeds this number of absences, the student may lose points due to late work or for excessive absences, which may affect the semester grade. Extended illnesses are handled on an individual basis and require verification from a doctor.

- b. **Administratively Excused Absences**—Only absences that are required by approved University activities are given administrative excuses. Students who must miss class for University-sponsored activities must follow these procedures:
 - (1) Inform the professor before the event and make arrangement for the work to be submitted prior to the absence or at a mutually agreed upon deadline.
 - (2) Present an administrative excuse form with appropriate signatures when he or she returns to class. Doctors' or nurses' notes, or letters from groups sponsoring mission trips or activities do not qualify a student for an administratively excused absence.
 - (3) Obtain information covered during an absence. All work must be completed as scheduled.
 - (4) Not commit to class presentation (oral reports, speeches, group presentations, etc.) on a date that the student will be gone. Makeup work is not permitted if the student voluntarily committed to a performance on the date of an administratively excused absence.
- 5. **Plagiarism**—Each student attending Oral Roberts University is required to do his or her own academic work and must not inappropriately collaborate with other students on assignments.
 - a. Students must document all sources and ideas that are not their own original information by following correct MLA (Modern Language Association) documentation procedures. Failure to do this produces a plagiarized paper, which results in an F for the paper. Flagrant cheating results in an F for the course.
 - b. Students may be asked to submit their assignments to Turnitin.com (an online anti-plagiarism program) or have their work submitted to D2L, which also submits work to Turnitin.com.
- 6. **Incompletes**—As stated in the University catalog, incompletes are granted only for "good cause," such as extended hospitalization, long-term illness, or a death in the family. Students must petition for an incomplete using the form available in the English and Modern Languages Department. Very few incompletes are granted.
- 7. **Whole Person Assessment**—If this course requires an ePortfolio assignment, it is listed in the next section ("Course Policies and Procedures") and explained in the WPA Handbook at http://eportfolio.oru.edu. Students need to comply as indicated in this syllabus, by the instructor, and in the WPA Handbooks.
- C. Course Policies and Procedure
 - 1. Evaluation Procedures
 - a. Grades are assigned according to the following scale: A: 90-100%; B: 80-89%; C: 70-79%; D: 60-69%; F: 0-59%.
 - b. Grades are determined as follows:
 - (1) **Topic Proposal (50 points)**: In consultation with the professor, the student selects a topic. He or she then creates a proposal: ½ 1 page describing the topic to be analyzed, and the author/s and work/s to be studied. The proposal also contains a bibliography of 10-15 critical sources, at least half of which must be in Spanish. The Topic Proposal is graded on: clarity and depth of proposal, and adherence to MLA guidelines.

- (2) Annotated Bibliography (50 points): The Annotated Bibliography should have 15-20 critical sources, at least 10 of which must be in Spanish. For each source, a student writes a ½ page summary of the content. Grades are based on adherence to MLA guidelines, as well as accuracy and completeness of the summaries.
- (3) Outlines (20 points): For each chapter of the senior paper, the student submits a detailed outline. The outline includes all points covered in that chapter, all literary passages analyzed, and all secondary sources cited. Information should be in outline form, rather than complete sentences, but must be complete enough to allow the professor to evaluate the content, organization, etc.
- (4) **First Drafts (40 points):** The first draft of each chapter is evaluated for depth (length, literary analysis, use of literary sources, use of secondary sources), organization (structure, use of transitions), language/vocabulary, and adherence to MLA guidelines.
- (5) **Final Drafts (50%):** The final draft should be well organized, well-edited, and clearly written. Evaluation of Final Drafts considers the same elements noted above (depth, organization, language/vocabulary, MLA guidelines), plus the student's responses to professor's comments on First Draft.
- (6) Whole Person Assessment (0% / -10%)
 - (a) As stated in the English and Modern Languages
 Department WPA Handbook, the following
 competencies apply to this course or the student must
 consult with the professor (10) Reading

Comprehension

- (b) To be "compliant" the student will have correctly submitted electronically the artifact for assessment. To be "noncompliant" the student has either not submitted or incorrectly submitted the artifact electronically.

 Noncompliance will result in one letter grade reduction of the final grade for the course.
- (c) It is the student's responsibility to ensure that he or she is in compliance. Compliance is verified by checking for the assessment results in the student's WPA. If there is a problem, the student may receive notification by the professor/assessor through the student's **ORU** email address.

2. Other Policies and/or Procedures

- a. At the beginning of the semester, the student and the professor create a calendar, indicating deadlines for completion of all work.
- b. The student will submit work to the dropbox on D2L.
- c. The complete Senior Paper should be 20 pages in length, and should follow MLA guidelines. This paper is subject for review by faculty members of the English and Modern Languages Department.
- d. Incompletes are granted only for medical or personal emergencies that occur during the last 2-3 weeks of the semester.
- e. The student binds the final draft of the senior paper and provides two copies to the English and Modern Languages Department.

f. Students who earn an A or B on the Senior Paper have the option to graduate with honors. The student who wishes to graduate with honors must publicly defend their papers at the end of the semester.
