Syllabus for

PRM 673—Introduction to Pastoral Care-ONLINE

3 Credit Hours Summer 2023

I. COURSE DESCRIPTION

This course is designed to help students become more knowledgeable, effective, and sensitive when ministering to persons in need. It covers selected topics in the field of pastoral care focusing on the work of the Christian minister implementing the care of God's people.

II. COURSE GOALS

The purpose of this course is to enable the student to do the following:

- A. Learn about the history and theology of pastoral care.
- B. Develop awareness of the privileges and responsibilities of a professional, caring person through readings, lectures, written papers, class discussions, projects, and/or exams.
- C. Become aware of information concerning issues such as pastoral diagnosis, intervention and prevention, death and dying, and developing caring communities.
- D. Learn that pastoral care can only be partly comprehended in a classroom setting, though the academic format can provide valuable resources for further personal and professional growth.

III. STUDENT LEARNING OUTCOMES FOR THIS COURSE

As a result of a successfully completing this course, the student will be able to do the following:

- A. Integrate and discuss the biblical meaning of pastoral care with modern pastoral procedures.
- B. Discuss the importance of having an appreciation for the history of pastoral care.
- C. Explain the significance of exercising pastoral authority in caring situations.
- D. Articulate a theological rationale for pastoral care through the writing of the term paper.
- E. Present a personal philosophy and model for pastoral care.
- F. Explain the need for caring for oneself, the family, and the congregation.
- G. Present ideas, either orally or in writing, on how to function as a pastor in crisis situations and cross-cultural situations.
- H. Compare and discuss various approaches for offering pastoral guidance and comfort for the dying and for persons experiencing grief.
- I. Discuss methods for training for pastoral care and preparations for practice in ministry and community settings.
- J. Discuss the importance of discovering ways to develop professional relationships with persons from other healing disciplines.
 Develop and articulate a theology and theory of ministry that is relevant to the student's background and calling.

- B. Graduate School of Theology and Ministry
 - 1. Completion of Assignments

Assignments are due on the dates established in the course calendar, which is published in the syllabus. Any assignments turned in after the scheduled due date are penalized five percent (5%) of the original value per day including

weekends, breaks, and holidays. All work turned in two weeks after the assignment deadline is received but is granted a grade of zero for that assignment. No work is accepted after the final date of regular classes.

2. **Incompletes**

- a. On rare occasions, the grade of "I" may be given for work that is incomplete at the end of the course semester due to a catastrophic event.
- b. The student must establish with the instructor and the director of the Modular/Distance Education Program that work is incomplete for good cause and submit a Petition for Incomplete Grade, with documentation.
- c. The Petition must be submitted at least two weeks prior to the end of the semester or summer course session, not exam week.
- d. The submission of a petition does not automatically ensure the granting of an Incomplete.
- e. The petition must be approved by the academic committee of the Graduate School of Theology and Ministry.
- f. It is the responsibility of the student to initiate the petition, make up any incomplete work, and submit a completed Request for Grade Change form (which has been signed by the course professor) to the academic office.
- g. If the work is not completed by the end of the subsequent semester, the incomplete will automatically convert to an "F," unless an extension is formally granted.

3. **Attendance**

The administration and faculty of the Graduate School of Theology and Ministry believe that class attendance is crucial in order for students to receive impartation, spiritual formation, and community experience. Therefore, the Official Attendance Policy for the GSTM is as follows:

- a. Students will receive one letter grade reduction after missing more than two weeks of classes.
- b. Students who miss more than one month of classes will fail the course.
- c. The absences allowed prior to a grade reduction are designed to allow for emergencies and illnesses and are not designed for indiscriminate use.
- d. Administrative excuses are granted only when a student is on official university business and has received approval in advance from the university administration.
- e. Students are expected to be prompt for classes.
- f. Students are expected to remain for the entire class session.
- g. Leaving early without permission constitutes an absence.

2. Whole Person Assessment Requirements

- a. All students, regardless of degree program, must submit The Ministry Observation Report for PRM 673 to the course professor on D2L.
- b. Failure to correctly submit designated artifact assignments on time to the course professor in the designated D2L dropbox will result in an Incomplete ("I") grade for the course. When a student submits the missing artifact to the professor, he or she may fill out the electronic Change of Grade Request Form found at petitions.oru.edu with all relevant information and submit it for the course professor.

3. Other Policies and/or Procedures

a. (50%) Weekly Online Discussions/Reflections

Students will do online discussions and reflections of the content of each book. Each week's student posts should include a list and description of three key ideas from the reading assignment and an explanation of how each idea is important in the student's personal ministry of pastoral care. Each student will also reflect and respond to another student's online post. Students should post their discussions and reflections to the reading assignment on or before 11:59 PM (Central Standard Time) Saturday each week. Details regarding each week's assignments will be posted on D2L.

b. (30%) Ministry Profile Report *

Students are to write and submit an 8 to 10-page ministry profile report based upon the purpose of observing changes related to the findings in the course and current ministry practice or an individual's future ministry practice. Students are to include references from course literature, scripture, and other resources. Your discussion will be based on observation from review of the two profiles; *The Spiritual Gifts Profile* (*SGP*) & *The Pastoral Care Profile* (*PCP*). The following queries will fulfill the required report/evaluation. Each under-lined topic heading must be in your paper.

- i. 4-5 Pages: Theology of Pastoral Care; Student is to reflect on their theology based on what; (a) the course related literature says, (b) what the biblical text and scriptural references support, and (c) what other theological resources confirm as the students Theology of Pastoral Care;
- ii. 1-2 Pages: <u>Vocational Practice</u>; reflect on the distinctive attributes from the SGP & PCP profile. What do they reveal about your calling and gifting's?
- iii. 1-2 Pages: <u>Caregiving Practice</u>; reflect on a church or community setting for one's present or possible future ministry or pastoral care context. Do the SGP & PCP profiles really say and reveal your ministry practice? What are those attributes seen in the profile? Are they accurate?
- iv. 2-3 Pages <u>Conclusions</u>; should be a summary based on what you observed about your gifts; Using the texts, power-points and reflections, etc., what has been strengthen in your understanding about your own cultural, biblical and theological practice for doing ministry in the future practical sense?

 *You may use answers from your discussions, colleague reflections and reading assignments.

c. (20%) Reflective Paper - The Choice

Students will write a 3-5 pages Reflective Paper based upon their reading of *The Choice* (2017) integrating self-reflection and discussion of other books and materials as related to the book's topics.

d. Attendance/Participation Zoom Sessions

Students are expected to be prompt and participate in any planned zoom sessions. It is expected that students will join with video and audio and remain on the zoom session for its entirety.
